





This report highlights the key research activities from our Department over the past 10 years. The Department of Renal Medicine at St George and Sutherland hospitals continues an active research program that is broadly focused on the following areas: hypertension and the progression of chronic kidney disease; hypertension and the renal disorders of pregnancy; more recently we have begun research in the field of renal palliative care.



Research remains integral to the practice of medicine and our department remains committed to ensuring the ongoing production of high quality research that is focused on clinically relevant questions. We are proud of our outcomes with over **200 papers** and book chapters and many presentations of this work over this period, including 26 publications in 2010 alone.

I would particularly like to thank Dr Sharon Ong, Belinda Trajkovska and Saiyini Pirabhahar for their considerable efforts in bringing this report together.

I hope you find this report of interest and that it stimulates ongoing research into the important areas of renal medicine and obstetric medicine.



## **Professor Mark Brown**

MBBS, MD, FRACP (Professor of Medicine, UNSW)



Professor Mark Brown completed his general nephrology training in Sydney 1983-1984 and in UK (1986). He was appointed as a staff specialist in renal medicine in 1987 and associate professor in 1993 and as professor in 2000. He has been the director of the Department of Renal medicine at St George Hospital since 1999. He has been a chairman of Medical Training & Education Council, director of NSW Institute of Medical Education & Training, director of JMO training, director of physician training (RACP) at St George Hospital and a member of Scientific Program and Education Committee, Australian & New Zealand Society of Nephrology.

Professor Brown has a long standing research interest in the Hypertensive and renal disorders of pregnancy. He was awarded his MD in 1988 on the subject of 'Sodium excretion in pregnancy.' His initial studies focused on exploring changes in renal physiology, particularly the renin-angiotensin system, in pre-eclampsia. Subsequent clinical studies have focused on improving methods to measure blood pressure and proteinuria in this disorder as well as predicting which women progress from gestational hypertension to pre-eclampsia. This work has led to the adoption of international recommendations for a standard method for sphygmomanometry blood pressure measurement and use of the spot urine protein: creatinine ratio to assess proteinuria rapidly in pregnancy. Subsequent research continues to focus on automated methods of recording blood pressure in pregnancy and the value of uric acid measurement in pre-eclampsia.

In recent years Professor Brown has also supervised research aimed at improving postgraduate medical education and assessing the impact of adjunctive palliative care in patients with chronic kidney disease. He has published 197 peer reviewed papers or book chapters and given 222 invited lectures.

## **Associate Professor John Kelly**

MBBS, MD, FRACP (Associate Professor of Medicine)



A/Prof Kelly completed his general nephrology training at St Vincent's Hospital, Sydney and the Royal Melbourne Hospital, Melbourne between 1987 and 1990. He completed his MD at the Garvan Institute for Medical Research, in Sydney and undertook further clinical research studies at Western General Hospital, Edinburgh University. He was appointed as a Lecturer in Medicine at University of New South Wales, St George Hospital Clinical School in 1993; Staff Specialist in Nephrology, St George Hospital in 1995, and Conjoint Associate Professor of Medicine University of New South Wales in 2001. He has held positions as Director of Physician Training at St George Hospital, and Council Member and

Honorary Executive Officer of the Australian and New Zealand Society of Nephrology. He has been a convenor of the New South Wales Renal Group since 1995, and is currently the coordinator of "Masterclass in Nephrology" teaching programmes for Basic Physician trainees in NSW.

A/Prof Kelly has a long-standing interest in the interactions between the endocrine and renal systems and their impact on body composition, blood pressure and vascular disease. His initial doctoral studies at the Garvan Institute were in the relationship between growth hormone, body composition and blood pressure regulation. At St George Hospital his primary area of research activity has been in mechanisms of corticosteroid mediated hypertension. His current clinical research activity is in the area of nutrition, and vascular disease in the early stages of chronic kidney disease. More recently, A/Prof Kelly has been involved as a collaborative investigator in a number of capacity building projects in South Pacific nations aimed at improving prevention and treatment of diabetes and diabetic complications such as diabetic kidney disease.

## **Associate Professor George Mangos**

MBBS, MD, FRACP (Associate Professor of Medicine)



A/Prof George Mangos is a nephrologist and Clinical Academic at St George Hospital and St George Clinical School UNSW. His clinical interests are in hypertension, renovascular disease, pregnancy medicine and interventional nephrology. His research interests are in blood pressure measurement, hypertension in pregnancy, and experimental hypertension.

George undertook his clinical nephrology training at St George and at Prince Henry Hospitals in Sydney before commencing his doctoral studies in steroid-induced hypertension. His subsequent research studies have included investigations into blood pressure

measurement and cardiovascular and metabolic outcomes of pre-eclampsia. He has a clinical and research interest in renovascular disease and has chaired the CARI group which published peer-reviewed guidelines on renovascular disease in 2010. He also chaired the nephrology curriculum group for the RACP and this curriculum is to be introduced into nephrology advanced training in Australasia in 2011. In 2008 he was promoted to Associate Professor and appointed Director, Integrated Clinical Training, Faculty of Medicine UNSW, and is currently Phase 3 Coordinator at St George Clincial School and PRINT Convenor. Presently he is keen to develop interventional nephrology in Australia.

#### **Dr Ivor Katz**

MBBCh, BSc (Hons), PhD



Dr Ivor Katz graduated in Medicine from the University of the Witwatersrand in Johannesburg South Africa (SA) in 1988. He spent the majority of his career, 20 years, at Chris Hani Baragwanath Hospital, in SA. His early years were spent as a research fellow in cardiology where he participated in research predominantly in the areas of hypertension and cardiomyopathy, under the mentorship of Professor Pinhas Sareli. It was during this time that he also completed an Honors Degree in Sports Medicine and Science at the University of Cape Town, under Professor Tim Noakes. At the same time as doing this post graduate research he also completed his Basic Physician Training from (1991-1994), before completing his Advanced Training in Nephrology (1995-

1996). He spent time working in medicine and renal departments in the United Kingdom. This experience helped him with the development of his then Renal Department in South Africa, where he was Head of Department for 12 years, 1996-2009. He was a senior consultant in the department of medicine from 1996 to 2009, working on the executive committee and recently moved to Australia in September 2009. He joined the St George Hospital Department of Renal Medicine as a Senior Staff Specialist and is currently the Director of the Haemodialysis Program. He is also the Director of Basic Physicians Training at St George and has enjoyed a long history of teaching and training undergraduate and post graduate medical students in general medicine and nephrology. Since completing his RACP Nephrology by peer review in September 2010, he is hoping to join the staff at the University of New South Wales in a conjoint position.



## **Dr Sharon Ong**

BSc (Med), MBBS, PhD, FRACP (Conjoint Lecturer, UNSW)



Dr Sharon Ong received her clinical nephrology training at the East Coast Renal Services: St George, Prince of Wales and Wollongong hospitals. Before her appointment as a Staff Specialist at the St George Renal Unit and Conjoint Lecturer at the University of New South Wales, she undertook PhD research studies at the John Curtin School of Medical Research in the Australian National University, under the supervision of Professor Judith Whitworth, investigating the mechanisms of glucocorticoid-induced hypertension. This involved studying the role of oxidative stress and nitric oxide-redox imbalance in the pathogenesis of this form of hypertension using a

range of physiological techniques and biochemical assays. She is currently overseeing the research activities within the Renal Unit and has interest in applying the insights gained into mechanisms of hypertension during her doctoral studies to clinical medicine. She is also the Director of the Peritoneal Dialysis Unit.

# Dr Parthasarathy Shanmugasundaram

MBBS, DM, FRACP (Conjoint Lecturer UNSW)



Dr Shanmugasundaram completed his medical education from Coimbatore Medical College, India (1995) and basic physician training from the prestigious 1300 bedded Post Graduate Institute of Medical Education and Research in Chandigarh, India (1998 to 2000). Here, he did a thesis on the secondary sexual characteristics and hormonal changes in patients with cirrhosis of the liver under the supervision of Dr R Muralidharan. In the same institute in 2001 to mid 2002, Dr Shanmugasundaram worked as a senior registrar in the Department of Medicine with special interest in Immunology, HIV medicine and Toxicology, where he was exposed to managing patients with immunological diseases, HIV infection and poisoning form organophosphate compounds and Aluminium phosphide in

particular. He went on to complete training at the Post Graduate Institute's Department of Nephrology (2002 to 2005) which is known to be the first centre in India to start an established Nephrology training program, under the directorship of Prof Vinay Sakhuja. Following this, Dr Shanmugasundaram worked as a Nephrologist at The Dr Inderjit Singh Memorial Health centre (Chandigarh) and helped establish a charitable dialysis centre.

He moved to Australia in September 2005, to work as an Advanced trainee in Nephrology with the East Cost Renal Service (till Dec 2007), and worked as a Renal Research and Clinical Fellow at the St George hospital from Jan 2008 to May 2009. Dr Shanmugasundaram was appointed as a Staff Specialist at St George and Sutherland Hospitals in June 2009. He has also been a conjoint Associate Lecturer at the University of New South Wales and hopes to work in the role of Director of Physician training at the Sutherland hospital from 2011. His interests include General Nephrology and Teaching.

Dr William Chan completed his PhD with Professor Posen at Sydney University from 1980 to 1983. His PhD thesis was titled "Studies in Azotaemic Osteodystrophy". He then did two years of post-doctoral research with Dr. E. Slatopolsky at Washington University in St. Louis, Missouri. Dr Chan started as a consultant at St. George Hospital in 1985, and has maintained an interest in calcium and phosphate metabolism as well as renal osteodystrophy.

# Dr Frank Brennan (Staff Specialist in Palliative Medicine)

MBBS, FRACP, FAChPM, LLB



Dr Brennan is a Palliative Care Physician based at St George and Calvary Hospitals. After a period of collaboration between the Departments of Nephrology and Palliative Medicine, Dr Brennan was appointed a Renal Palliative Care Physician at St George Hospital in late 2010. It is the first position of its kind in Australia.

That appointment coincided with the appointment of two separate 0.5 positions as a Renal Supportive Care Nurse - one at St George Hospital (Elizabeth Josland) and one based at Tamworth (Gloria O'Connor). A Renal Supportive Care Clinic was established in March 2009 and now runs weekly. Dr Brennan is also a lawyer and

has written extensively on the human rights dimensions of pain management and Palliative Care.

#### Saiyini Pirabhahar (Research Officer)

Saiyini Pirabhahar completed her Bachelor of Nursing degree from Royal Melbourne Institute of Technology (RMIT) in 1994 and completed her graduate training in Box Hill hospital in Melbourne in 1996. She developed interest in chronic diseases and went on to complete her Graduate Diploma in Medical Laboratory Science in 1998 from RMIT. During this she was working as a technical officer at Gribbles Pathology. She then moved on to work as a research assistant at the Department of Medicine at Monash University. She then relocated herself to Sydney in year 2000 and has been part of the St George Hospital team.

Paula Williamson worked as a Research Officer with Professor Judith Whitworth at the University of New South Wales based at the St George Hospital Renal Hypertension Unit from 1991 to 2009. Her work was mainly specialised into the area of corticosteroid hypertension. However she has also worked on several research studies in hypertension in pregnancy and chronic kidney disease.






